

Special Resolution to Award HLMS

This Union Notes:

1. Section III D, and IV A 1-4 of the Constitution which reads as follows:

III. Membership: Eligibility

D. Honorary Life Membership of the Union may be granted by a Special Resolution of Union Council.

IV. Membership: Privileges

A. Every member of the Union shall be entitled to the privileges as shown below:

- 1. to use the rooms and facilities of the Union in accordance with regulations approved by Union Council;*
- 2. to attend and bring visitors to functions in accordance with regulations approved by Union Council;*
- 3. to membership of any or all Clubs and Societies subject to their regulations;*
- 4. to membership in the case of male members of the Men's Union Society and in the case of female members of the Women's Union Society.¹*

2. That Union Colours committee has resolved to recommend to Council that 10 individuals be awarded Honorary Life Membership of UCL Union.
3. That 3 of these individuals have already been awarded Honorary Life Membership once, and so are not gaining any extra privileges by receiving it again. These are Jen Currigan, Kate Rowley, and Dan Swerdlow.²

This Union Believes:

1. That the individuals listed below in 'This Union Resolves' have all made significant contributions to the union over a sustained period of time, and meet the criteria laid down in the standing orders for the receipt of Honorary Life Membership.
2. That therefore they deserve to receive this award and the privileges that go with it.

¹ Please note that the membership privileges laid out in section IV A are available to all types of members as opposed to those in section IV B which are only available to those who are ordinary members (i.e. currently registered Students of UCL).


